Compliance Assistance Corner

Ask a pesticide applicator treating landscaped areas what they are using. they often say "Roundup" even when the product may indeed be something other than Roundup.

Roundup is a commercial brand name for a suite of pesticide products manufactured and marketed by Bayer Crop Science. There are many products in this line, Roundup Weed & Grass Killer (Reg. No. 71995–68), Roundup Pro Concentrate (Reg. No. 524–529) and Roundup PowerMAX 3 Herbicide (Reg. No. 524–659), to name a few.

Although they are marketed under the commercial brand name of "Roundup" each product is different and may even have different active ingredients. Not all Roundup products have Glyphosate in their formulation.

lists multiple products under this brand; many with unique formulations of active ingredients, unique pesticide labels, and unique EPA Reg. No.

Competing products, which attempt to mimic the active ingredient formulation and mode of action, are also available, and unfortunately are often referred to by applicators as "Roundup".

Although the product may be similar, these competing products may also have their own unique formulation of active ingredients, their own unique pesticide label and are registered with the EPA with their own unique EPA Reg. No.

It is important to know...When applying pesticide products, it is necessary that applicators be familiar with and follow the pesticide label for the specific product they are using.



Remember, the pesticide label is the law.
